The individuals listed below are provided to ERMA members as a resource in choosing a workplace investigator. Please note, however, that this is not a pre-approved list. Pursuant to ERMA Resolution No. 3-2007 (Establishing Criteria for Approval of Investigators), if an investigation pertains to an ERMA matter, you must first report the claim to ERMA and obtain written approval from the Litigation Manager prior to engaging an investigator in order for any expenses to count toward your Self-Insured Retention. Resolution 1-2014 caps an investigator's hourly rate at \$210 per hour for attorney investigators and \$195 per hour for non-attorney investigators.
